EC – Declaration of conformity regarding Regulation EC/1907/2006 (REACH)

The Chemicals Regulation (EC) No 1907/2006 concerning the registration, evaluation and authorisation of chemicals (REACH) entered into force on 1st June 2007. It defines requirements on substances as such, substances in mixtures and also certain substances in articles.

For products requiring a safety data sheet SDS they are provided via download on our web based product catalogue under

Please consider that products as tapes, gel joints, cable ties, joint bodies, plugs and heat shrink products comply with the REACH definition of articles. "*Article: means an object which during production is given a special shape, surface or design which determines its function to a greater degree than does its chemical composition;*" (REACH Art. 3). For those products it is therefore not mandatory to create safety data sheets according to REACH Art. 31.

To protect the general public via communication and prevention regarding hazardous substances without the necessity of a safety data sheet some materials are regulated or prohibited. (Art. 67 and Annex XVII REACH).

Hazardous substances that are not regulated or prohibited, but are of very high concern due to their effects on health or the environment (Art. 57 REACH), are listed in Annex XIV as SVHCs (substance of very high concern). Also for articles the presence of these substances must be declared, if the concentration exceeds 0.1 % (Art. 33 REACH). The manufacturer, downstream user and importer is committed to supply sufficient information for safe handling of articles containing SVHCs. At least he must declare the substance identity.

As a producer and supplier of articles Cellpack GmbH is aware of the requirements on substances in articles according to REACH. We are monitoring the development of the candidate list and keep information about the presence/absence of SVHC from our suppliers up to date.


